Dear Parent:

The Mifflin County School District is conducting registration for children who will be eligible for enrollment in a kindergarten class for the 2019-2020 school year. Registration will be held at Strodes Mills Elementary on March 6 & 7, East Derry Elementary on March 12 & 13, Indian Valley Elementary on March 19 & 20, and Lewistown Elementary on March 26-28. Appointments will be scheduled during the school day.

Information gathered from this form will enable the District to properly plan for its new enrollees and will provide an opportunity for school officials to communicate directly with parents and guardians concerning enrollment requirements.

Proper enrollment for school includes a physical examination performed within one year of the start of the 2019-2020 school year, verification of birth date, proper immunization, proof of residence., and custody agreements/court orders (if applicable). Once enrolled, a preschool kindergarten assessment to determine learning potential is administered to each child prior to the beginning of school. While this assessment has no bearing on eligibility for enrollment, it does aid the school in structuring meaningful and appropriate educational programs for new students. Once your child is registered you will receive more information about the assessment program.
