Authority P.L. 108-265 Sec. 204	To ensure the health and well-being of all students, the Board establishes that the district shall provide to students: A comprehensive nutrition program consistent with federal and state requirements. Access at reasonable cost to foods and beverages that meet established nutritional guidelines. Delegation of Responsibility Pol. 808	The Superintendent or designee shall be responsible to monitor district schools, programs, and curriculum to ensure compliance with this policy, related policies and established guidelines, and administrative regulations. Each building principal or designee shall report to the Superintendent or designee regarding compliance in his/her school. Staff members responsible for programs related to student wellness shall report to the Superintendent or designee regarding the status of such programs.	23 24 25 26 27 28 29 30 31 32
	P.L. 108-265 Sec. 204	The Superintendent or designee shall annually report to the Board on the district's compliance with law and policies related to student wellness.
