Parent/Guardian AM Drop Off/PM Pick up Procedures

<u>Morning drop off</u> - Watch the video <u>here!</u> Make sure children exit the car on the right. After dropping off your student, you will turn left to exit the same way you entered.



<u>Afternoon pick up</u> - similar to the drop off, drive around the back of the building (toward the playground), make a U-turn and form a line. Remain in your car and drive up to the numbered spots. We will send your child out as you pull up to the numbered spaces.



School Wide Positive Behavior Supports and Interventions (PBIS)

You may hear your student say they earned points at school. Each student will have the opportunity to earn points on a daily basis for following the school wide rules. Those points can then be redeemed at our online school store! Students will shop while at school and those items will be delivered directly to their classroom.

Free and Reduced Lunch and instructional supplies for those who qualify

MCSD also ensures that no student in the school is denied participation to school programs for financial reasons. Students who qualify for the free and reduced lunch program will also be provided necessary school supplies when the proper form is completed by the parent/guardian. You may request an application for instructional supplies by contacting the main office or administration.

Title 1 Federal Funds - Right to Know

As a parent of a student attending a school that is receiving Federal Title I dollars, you have the right to know the professional qualifications of the teacher(s) and instructional paraprofessional(s) who instruct your child.

Federal law requires every Title I school district to comply and to provide you with the requested information in a timely manner.

We are happy to provide this information to you. At any time, you may ask:

- Whether the teacher met state qualifications and certification requirements for the grade level and subject he/she is teaching,
- Whether the teacher received an emergency or conditional certificate through which state qualifications were waived, and
- What undergraduate or graduate degrees the teacher holds, including graduate certificates and additional degrees, and major(s) or area(s) of concentration.

You may also ask whether your child receives help from a paraprofessional. If your child receives this assistance, we can provide you with information about the paraprofessional's qualifications.

The Every Student Succeeds Act (ESSA) which was signed into law in December 2015 and reauthorizes the Elementary and Secondary Education Act of 1956 (ESEA) includes additional right to know requests. At any time, parents and family members can request:

- Information on policies regarding student participation in assessments and procedures for opting out, and
- Information on required assessments that include
 - o subject matter tested,
 - o purpose of the test,
 - o source of the requirement (if applicable),
 - o amount of time it takes students to complete the test, and
 - time and format of disseminating results.

Our staff is committed to helping your child develop the academic knowledge and critical thinking he/she needs to succeed in school and beyond. That commitment includes making sure that all of our teachers and paraprofessionals meet applicable Pennsylvania state requirements.
