The Mifflin County School District offers a comprehensive program to assist and monitor students' progress towards meeting the challenging State academic standards. Teachers, principals, parents, families, Chief Academic Officer, and the Federal Programs Coordinator work as a team to review the needs of students at each respective school to support the mission of ensuring that all students meet or make growth towards grade level goals in reading and mathematics. Classroom, Title 1, special education teachers and building principal will meet as a grade level team at the beginning of the year to discuss grade level data. These group data meetings will be used to identify and support students struggling in English Language Arts and Mathematics. Students will be identified based on the level of instructional need. Students will receive differentiated instruction in the core, Tier I instruction. Students identified with Tier II and Tier III needs will be given additional time for instruction and placed in flexible learning groups. These groups will be organized based on student learning needs. Students found to have a greater need will be referred to the building's problem-solving team (PST) process. Throughout the year, the data will be used to realign teaching resources and adjust schedules as needed. Highly qualified teachers, reading specialists, and special education teachers will provide instructional support among the Tiers.

We will provide parents and families of students who are struggling in the areas of math and reading with MTSS progress reports. We will invite parents and families to schedule Problem Solving team conferences to discuss their child's progress, review state and local assessment data and plan strategies to complement their child's instruction.
